TERM:

A Salute To Love - Complete Wedding Giveaway (the "Giveaway"), Presented by Moulliet Productions (the "Presenter") entry period commences at 12:01 a.m. Eastern Daylight Time on **June 1, 2020**, and will be accepted until 11:59 p.m. Eastern Daylight Time on **August 31, 2020** (the "Contest Period").

ELIGIBILITY:

A Salute To Love - Complete Wedding Giveaway, Presented by Moulliet Productions, is open only to legal residents of the 50 United States and the District of Columbia who are on active service with the United States military (ranks E-1 thru E-5) at the time of entry. Proof of service will be required. Employees, officers, directors and representatives of Moulliet Productions and immediate family members and household members are ineligible to enter or win the prize. "Immediate family members" shall mean spouse, parents, step-parents, legal guardians, children, step-children, siblings and step-siblings and each of their respective spouses. "Household members" shall mean those people who share the same residence at least three months a year. Void where prohibited by law.

SUBMISSION:

To enter, write an essay or create a video explaining why you feel you should be selected for the wedding giveaway. If you created a video, upload the video to YouTube and submit the URL no later than **August 31, 2020**. Email your essay with a picture of you and your significant other or the URL of the video to mywedding@moullietproductions.com .

All entries must include the following:

- name (both bride and groom)
- street address

- telephone number
- date of birth (both bride and groom)
- military unit name (of military member)
- military base of assignment (of military member)
- military rank (of military member)
- length of time in service (of military member)

Limit one (1) entry per email address. All entries generated by a script, macro or other automated/repetitive electronic means will be disqualified and ineligible for the Giveaway. Presenter not responsible for lost, illegible, incomplete, mutilated or stolen entries; errors appearing on the entry form, within these Official Rules, or in any Contest-related advertisements or other materials; or other errors of any kind, whether mechanical, human, electronic or otherwise. Normal Internet access and usage charges imposed by your online carrier apply. An entry made via the Internet will be deemed to have been made by the "authorized account holder" of the email address utilized at the time the entry is made. For purposes herein, the "authorized account holder" refers to the person assigned to an email address by an Internet access provider, online service provider, or other organization responsible for assigning email addresses. Entries that are late, illegible, incomplete, lost, tampered with, incomprehensible, forged, misdirected, inaccurate or otherwise not in compliance with these Official Rules will be disqualified. All requested information on the entry form must be completed in English to enter and be eligible. By entering the Giveaway, each entrant hereby agrees that Presenter may use the personal information collected from entrant for the purpose of administering the Giveaway, fulfilling prizes and providing entrant with information relating to Presenter or its affiliates and each of their respective products, services and promotions. Presenter will not sell, share or otherwise disclose an entrant's personal information to a third party, other than to those engaged by Presenter to fulfill the above purposes, without the entrant's permission. All entries become the property of Presenter and will not be returned.

PRIZE RESTRICTIONS: The Giveaway, must be redeemed by **October 30, 2020**.

All incidental expenses and taxes not specified herein will be the sole responsibility of the winner and his/her, bride/groom

and their travel companions (wedding party), including, without limitation, other ground transportation, food, and beverages. The Prize Winner ("Prize Winner") and his/her prospective bride/groom must be present on the chosen wedding to redeem the Giveaway prize package. Prize Winner is solely responsible for their travel and the travel of their guests to the event location.

CONTEST RESTRICTIONS:

The Submission must be in English and no more than 250 words in length; YouTube video max length is 10 minutes; The Submission must not contain material that violates or infringes upon another's rights, including but not limited to privacy, publicity or intellectual property rights, or that which constitutes copyright infringement; The Submission must not disparage Presenter or any other persons or parties affiliated with the Giveaway; The Submission must not contain brand names or trademarks other than those owned by Presenter; Entrant has a limited license to use Presenter's brand names and/or trademarks to incorporate in his/her Submission in this Contest; The Submission must not contain material that is inappropriate, indecent, obscene, hateful, tortuous, defamatory, slanderous or libelous; The Submission must not contain material that promotes bigotry, racism, hatred or harm against any group or individual or promotes discrimination based on race, gender, religion, nationality, disability, sexual orientation or age; The Submission must not contain material that is unlawful, in violation of or contrary to the laws or regulations in any state where Submission is created; Entrants (bride and groom) described in the Submission must be at 18 years of age.

WINNER DETERMINATION:

Contest: The Contest winner will be determined through the process outlined below:

i. Initial Judging Phase: During the Initial Judging Phase, Presenter will score the submissions based on the following criteria:

- Creativity/Originality (33%);
- Quality of Submission (33%); and
- Relevance to A Salute To Love (34%)

The five highest-scoring submissions will proceed to the Official Panel voting phase.

In the event of a tie, the entrant whose Submission received the highest score for the "Relevance to A Salute To Love" criterion, as determined by the qualified judges, will be deemed a Finalist. Presenter reserves the right to select fewer than five (5) Finalists if, in its sole discretion, it does not receive a sufficient number of eligible and qualified Submissions.

ii. Official Panel Voting Phase: During the Official Panel Voting Phase, the Finalists' essay Submissions and/or video submissions will be forwarded to Official Panel for selection of winner couple.

In the event of a tie for the Prize, the entrant whose Submission received the highest score for the "Relevance to A Salute To Love" criterion during the Initial Judging Phase will be deemed the Prize Winner. Presenter reserves the right, in its sole discretion, to select an alternate Prize Winner should the voting appear to have been tampered with or manipulated in any way.

iii. Alternate Prize Award

If the Prize Winner is disqualified for any reason, the finalist who received the second highest voting score will be named Prize winner. Only three (3) alternate Prize Winners will be determined, if necessary, after which the applicable prize may remain un-awarded.

In the event of a tie for the Prize, the entrant whose Submission received the highest score for the "Relevance to A Salute To Love" criterion during the Initial Judging Phase will be deemed the Prize Winner. Presenter reserves the right, in its sole discretion, to select an alternate Prize Winner should the voting appear to have been tampered with or manipulated in any way.

WINNER ANNOUCEMENT:

The Prize Winner will be notified by mail, e-mail or phone on or near **October 1, 2020**.

WINNER REQUIREMENTS:

Each Finalist will be required to sign and return an Affidavit of Eligibility, Liability & Publicity Release ("Affidavit"). The Affidavit must be received by Presenter within five (5) days of the date notice or attempted notice is sent. If any Finalist cannot be contacted or fails to execute and return the Affidavit within the required time period, such Finalist forfeits his/her chance to participate in the Voting Phase for the Prize. Acceptance of any prize shall constitute and signify winner's agreement and consent that Presenter and its designees may use the winner's name, city, state, likeness, photo, Submission

and/or prize information in connection with the Giveaway, advertising or other purposes, worldwide, in any and all media now known or hereafter devised, including the Internet, without limitation and without further payment, notification, permission or other consideration, except where prohibited by law. If and to the extent such damage or loss (including costs and expenses) as covered by this indemnification is paid by the State Tort Claims Trust Fund, the State Authority Liability Trust Fund, the State Employee Broad Form Liability Fund, the State Insurance and Hazard Reserve Fund, and other self-insured funds (all such funds, collectively the "Funds") established and maintained by the State of Georgia Department of Administrative Services Risk Management Division (hereinafter "DOAS") the entrant agrees to reimburse the Funds for such monies paid out by the Funds. This indemnification does not extend to claims for losses or injuries or damages incurred directly by the Released Parties due to the sole negligence or Willful Misconduct of the Released Parties. "Willful Misconduct" means an intentional, wrongful act of a person, or such person's intentional disregard of a manifest duty, done either (i) with knowledge that such conduct will cause serious hardship to another person, or (ii) with wanton and reckless disregard of the possible consequences of such conduct.

waiver of that provision.

DISPUTES:

All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the entrant and Presenter in connection with the Giveaway, shall be governed by, and construed in accordance with, the laws of the State of Georgia without giving effect to any choice of law or conflict of law rules, which would cause the application of the laws of any jurisdiction other than the State of Georgia.
